

**AMENDMENT ONE**  
**PROFESSIONAL SERVICES AGREEMENT**  
**~ Parking Consulting Services ~**

This Amendment One to the Professional Services Agreement ("A1") is made effective this 6th day of October 2020 by and between the Eagle Urban Renewal Agency, an independent public body corporate and politic, organized and existing under the laws of the State of Idaho ("EURA"), and Kimley-Horn and Associates, Inc., a North Carolina corporation authorized to do business in Idaho. (referred to herein as "Consultant").

WHEREAS, EURA and Consultant entered in to a Professional Services Agreement dated September 15, 2020 ("Agreement") for Consultant to provide a comprehensive downtown parking study;

WHEREAS, Exhibit A to the Agreement included a table which noted hourly rates for the Consultant staff which were not correct and the parties desire to amend the Agreement and replace the hourly rate table with the correct hourly rates and the parties acknowledge that this A1 will not alter the not to exceed amount under the Agreement;

WHEREAS, EURA and Consultant desire to enter into this Agreement in furtherance of the public purpose, goals and objectives of EURA and its Board of Commissioners.

NOW THEREFORE, for the mutual covenants and consideration contained herein, the sufficiency of which is hereby acknowledged, the parties agree as follows:

**~ AGREEMENT ~**

1. The EURA and Consultant agree to amend the Agreement by deleting the Table entitled "Raw Hourly Rates" in Exhibit A under the heading "Billable Rates and Expenses" which describes the hourly rates for the Consultant staff. That deleted table shall be replaced with the following table:
